## SENATE BILL 1383 FOOD DONATION REQUIREMENT

As you may be aware, Senate Bill 1383, among other things, requires every jurisdiction to develop a food donation program. Not only is it a Statewide requirement, but there is a significant social need to expand food donation. Each year, businesses and residents in Los Angeles County throw away over 2.5 billion pounds of food, equivalent to about 2 billion meals, while 1 in 7 people are food insecure. This statistic is even worse for children, where 1 out of 5 lack regular access to nutritious food.

Los Angeles County Public Works launched the Food Donation and Recovery Outreach Program (Food DROP) in January 2018 to address these needs in the Unincorporated Los Angeles County, however the information and resources can be utilized throughout the entire Los Angeles County. Food DROP's priorities are to raise awareness of food insecurity, reduce food waste, and fight hunger by connecting businesses with excess food to non-profits that distribute the food to those in need. We believe our program can be a good model for Cities to consider and welcome review of our process, outreach materials, and other resources.

Public Works may be able to assist you to get implement or expand a similar program if you are already underway, as the Senate Bill 1383 organic waste regulations will require all jurisdictions to implement an edible food recovery program to identify and educate commercial edible food generators, monitor food recovery activities, and increase edible food recovery capacity. In order to help the most people in need and maximize the amount of edible food kept from being disposed, we would like to coordinate among all Cities. Together, we can share what has been developed to comply with this requirement of the regulation and learn best practices in diverting surplus edible food.

Specifically, Food DROP provides resources for businesses operating in Los Angeles County to safely donate their excess edible food. In the past 2 years, Food DROP identified large edible food generating businesses in the Unincorporated Los Angeles County, conducted site visits/phone surveys, provided educational outreach and consultations to the identified businesses, and connected them with non-profit partners
