Background

LA County Board of Supervisors adopted the Roadmap in October 2014



County of Los Angeles Department of Public Works

October 2014

- Established Long-term Waste Diversion Targets
- 80% by 2025
- 90% by 2035
 - 95% by 2045

- SB 1383 Organic Waste Diversion
- SD3 Motion and Report Recommendation
- Stakeholder Feedback
